

Minutes of the Great Burstead and South Green Village Council meeting, held at South Green Memorial Hall, Southend Road, Billericay on Wednesday 7<sup>th</sup> February 2024 at 8:00 p.m.

#### 24/21 Declarations of Interest & Register of Members Interests

No declaration were received.

#### 24/22 Minutes

The Minutes of the meeting on 3<sup>rd</sup> January 2024 were received, and duly signed by the Chair of the meeting as a true record of the meeting

# 24/23 Public participation session with respect to items on the agenda and other matters, which are of mutual interest. No decisions to be made.

Residents from Tyrells Road attended the meeting to explain their distress at the latest situation following the flood preventions works that were carried out by Essex County Council in the road in 2023. The planted rain garden area had recently been sprayed with industrial weed killer leading to the area looking in a terrible state and residents felt that prior warning should have been given to keep pets and children safe from the area. The raised edging of the rain garden has also led to several residents tripping and falling. Overall, there have not actually been any improvements to the flooding issues, and new pools of water are forming in places they did not prior to the works.

Residents explained they have continued to contact Essex Flood Department but only receive a standard response back. The Chair advised that further complaints must be made to try to get a resolution to both the visual amenity of the road and the flooding issues. Cllr Crowe suggested contacting the Local Government & Social Care Ombudsman. Residents felt strongly that Cllr Moore as Cllr for Burstead Ward and County Councillor for the Billericay & Burstead Division should come to visit the road and help residents. Clerk to contact Cllr Moore and assist the residents with their efforts where possible.

Prior to the meeting a resident from Church Street had contacted the Clerk wishing to make an official complaint regarding the new refuse collection system. She explained she had several missed collections, which she reported but to no result. Hers and her neighbours' bags had also often flown around the street. The residents of Tyrells Road present at the meeting agreed with these comments.

Members noted the complaint and sympathised with the resident's discontentment of the new recycling service.

The following ideas were put forward: Archer (Close/Way/Road) Longbowman (Close/Way/Road) - an archer who uses a longbow Bow (Close/Way/Road) Bowman (Close/Way/Road) - an archer Bracer (Close/Way/Road) - an arm-guard Fletcher (Close/Way/Road) - an arrow maker Quiver (Close/Way/Road) - a container for carrying arrows Yew (Close/Way/Road) - the wood used to make a bow

# 24/33 Placement of Bollards around the Parking Bay at South Green Parade of Shops - Tescos to Tylers Estates

The latest update received is that the engineers are checking the underground STATS. The Design Team Leader is due to visit the site.

## 21/34 Road safety – Hickstars Lane service road

Members discussed the concerns for safety along this stretch of road following reports of vehicles travelling along here. Cllrs also raised the concern that some vehicles are entering the shopping parade car park from the wrong entrance due to the road markings being worn away. The Clerk had contacted Essex Highways and been advised that a speed survey would need to be carried out (at a cost of £400). Clerk to contact Cllr Moore to request traffic calming measures be investigated and all agreed that the Village Council could help finance these road safety improvements.
