24/01355/FULL	7 Fieldfare Billericay Essex CM11 2PA	Demolition of existing garage, part single and part two storey front, side and rear extensions, new bathroom window to side.	The Village Council object to this application as it is considered to be overdevelopment of the site and would be out of keeping with the street scene. There are concerns the building would be too close to the boundary line. It was noted that another property along the road has had a similar extension but respects the boundary rules.
24/01047/OUT	Blackthorn Stud Kennel Lane Billericay Essex	Proposed development to provide eleven dwellings (outline application with all matters reserved except for access) -	The Village Council object to the application as it is on Green Belt land, the Village Council feel strongly that Green Belt land must be protected. The Council also objects due to the accumulative effect of other applications in close proximity to this application and the therefore detrimental effect yet more homes will have for the current residents and the area. Across the road there is a potential application for 200 homes. The already congested roads in the vicinity cannot accommodate more vehicles. This site is situated on a winding narrow country lane, it is already a dangerous stretch of road where a road traffic fatality has occurred. There would be no footpath for residents to safely travel to local amenities and there are no public transport links available from Kennel Lane. Further homes will add to the deficiencies in social facilities in the area - the local schools are already above their capacity, and from March 2025 there will no longer be a Doctors Surgery within the Parish.

25/7 Local Plan Regulation 18 Consultation

Following a meeting of the Local Plan Working Party Village Councillors' comments on each of the proposed development areas were submitted and collated. Then a formal response incorporating those comments was formulated by the Chair of the Village Council.

Members reviewed the document prior to the meeting.

The final version was approved at the meeting and will be sent to Basildon Council both via email and hand delivered. Members agreed that a letter be sent to our MP requesting a meeting to discuss the Local Plan and the closure of the South Green Surgery. Members also requested that a Planning Officer be invited to a meeting to explain the planning process in relation to the Local Plan.
