23/122 Declarations of Interest & Register of Members Interests

No declarations were submitted.

23/123 Minutes

The Minutes of the meeting on 3^{rd} May 2023, were received, and duly signed by the Chair of the meeting as a true record of the meeting

23/124 Public participation session with respect to items on the agenda and other matters, which are of mutual interest. No decisions to be made.

Residents from homes in Tyrrells Road attended the meeting to discuss further the floods works carried out by Essex Highways. The Clerk had invited a representative from the Flood Essex department and Cllr R Moore from Essex County Council to attend and the residents were disappointed that neither were present.

The Chair read out an email response the Clerk had received from Flood Essex. Residents had prepared a document detailing the flooding problems they have experienced and their concerns that the works carried out may not successfully deal with the flooding issues to some homes in Tyrrells Road. Some residents had contacted the Essex Council to apply for grants and the Council had suggested for these homes to install a flood door. The works began sometime after this and it is not clear if the works that then commenced were in response to these communications or not.

The Village Council support the residents in their aim to have the greensward levelled and restore to lawn and will continue to investigate the reasons for the works being carried out such as they have.

Residents plan to continue to contact Essex County Cllrs and in addition the local press to share their plight.

Another member of public attended to enquire if the Village Council could report the faded pedestrian crossing markings, which are in need of repainting and currently a danger as they are no longer visible to motorists. She also wanted to inform the Council that there is a loose branch on one of the trees on the Village Green.
